If you or your representative has an annual tax bill of at least \$300,000—whether on a single property or as the total tax liability of multiple properties—you will be assessed a 1% penalty charge on payments that are not made electronically using the “pay online” link above.

If you own income-producing property, you must file a Real Property Income and Expense (RPIE) statement or a claim of exclusion unless you are exempt by law. You must also file information about any ground or second floor storefront units on the premises, even if you are exempt from filing an RPIE statement. RPIE filers whose properties have an actual assessed value of \$750,000 or greater will be required to file rent roll information. The deadline to file is June 3, 2024.
