- 3. **Schedule** your online payment using your checking or savings account.

The deadline to register this information is **June 1, 2021.** Failure to do so will result in penalties and interest, which will become a lien on your property if they go unpaid. The BID assessment includes an adjustment due to a billing correction from a prior year.
